Getting More Children and Families into Evidence-Based Treatment (EBT)

- 1. Connect more families to existing EBT
 - Provider registries
 - Care coordinators/health navigators
 - System of care
 - Group-delivered treatment
- 2. Increase the number of families seeking EBT
 - Reduce stigma/raise awareness of benefits of EBT
 - Raise awareness among referring physicians
 - Medication-related (e.g., prior authorization) policies



Getting More Children and Families into Evidence-Based Treatment (EBT)

- 3. Provide EBT in more locations
 - Telemental health (remotely delivered EBT)
 - School-based health centers
 - Schools as underutilized facilities
 - EBT integrated into primary care (co-location)
 - Federally Qualified Health Centers
 - Parents' workplaces







4. Increase the number of EBT providers

- Increase number or geographic spread of licensed providers
- Enhanced services from primary care (e.g., Project ECHO, consultation)
- Lower-intensity EBT by other early childhood professionals
- Peer-provider models
- 5. Incentivize EBT over non-EBT
 - Preferred provider lists
 - Value-based payment systems


